## Case Examples

### Professional negligence:

Alleged negligent survey of new dwelling permeated with dry rot.

Failure to provide appropriate insurance for mobile home site

Failure by solicitors to properly register title or to accurately record boundaries.

Accountants and/or solicitors advising transfer of farm land into discretionary trust resulting in avoidable high CGT bill.

Alleged failure to advise upon overage provisions in transfer of land.

### Landlord and Tenant

Dilapidations claim with dispute as to future intended use and s18 cap.

Disputed validity of break notice and option.

Dispute as to termination of taxi business lease and consequences.

Conflict of business tenancy and service occupancy rights relating to industrial social club.

### Partnership

Assisting a nine partner firm to agree terms for retirement, new partnership and treatment of clients.

Dispute between partners and directors relating to provision of insurance services with allegations of dishonesty and unlawful use of confidential information.

### Compulsory Purchase

Quantification of losses arising out of blight notice on business premises.

Compensation on blight following road widening scheme and closure of major motor car franchise business.

### Banking and mortgage

Claim for possession defended on basis of fraudulent mortgage and undue influence.

Mortgage claim alleging misrepresentation of liabilities and mis-selling of product.

### Contentious Probate and Trust

Dispute between siblings as to inheritance of £4m buy-to-let portfolio.

Dispute between natural son and stepmother as to inheritance of farm and reasonable financial provision.

Dispute between beneficiaries (not related to deceased) under a will, close relatives and an animal charity as to inheritance of land and capital assets, and concerning mental capacity of deceased.

Dispute between University, government agency and farm trust as objects of trust, statutory obligations and use of land.

Widow's challenge to will concerning interrelation of Japanese and English probate and pension law.

### **Easements boundaries and covenants:**

Subsidence claims arising out of tree root encroachment or heave.

Neighbour claim including disputed title deeds, adverse possession, rights of way, rights of light, drainage, and covenants restricting business use.

Multi-million pound claim arising out of multiple and long-standing discharge of sewage by statutory undertaker into private watercourse.

Damage to fishing rights by riverbed excavation and by polluted discharge

Damage to shooting rights by farming techniques.

Rights of light claim arising out extension of major London football stadium.

### **Building and construction**

Claim in respect of new build suffering regular flooding

Commercial agricultural buildings constructed on unsuitable ground glass foundations

Claim between adjoining social housing organisations

### **Corporate and insolvency**

Alleged misrepresentation on share purchase agreement

Claim relating to alleged preferences and wrongful trading

Alleged transactions at an undervalue and issues under sections 238, 239 and 424 of the Insolvency Act 1986.

### **Contract, commercial and statutory rights**

£11million claim relating to provision of emergency accommodation for Local Authority.

Claim relating to supply and fit of control panels and associated software.

Claim relating to supply of defective space heaters to major internet and high street retailer.

Dispute between computer hardware supplier and air conditioning installer as to cause of computer failure for Government security organisation and losses flowing.

Claim and counterclaim arising out of food franchising contracts.
